FAQ Consigning with Us

How do you choose what to consign?

Mirror Mirror Clothing Shop provides a great opportunity for you to sell your clothes and accessories that you may no longer want. Our reputation is based on the quality of the items that we sell in the shop. Therefore, we are very selective in what we take on consignment. We base it on what we know will sell the best. We hope you will understand if we do not accept some of your items.

Merchandise must be:

- In new, or like-new, condition
- Freshly laundered (preferably with unscented detergent)
- On hangers
- In excellent condition free of stains, smoke, pet hair, pills, rips, broken zippers, missing buttons

Shoes must be scuff free, and need to be wiped down inside and out.

When do you accept consignments?

We use the schedule below:

Spring: March

Summer: June

Fall: September

Winter: December

Please call 518-325-4000 to make an appointment. We accept up to 15 pieces at one time.

What types of merchandise are you mostly looking for?

Spring:

- Jeans, pants, capris, skirts
- Long sleeve tops
- Lightweight jackets
- Lightweight sweaters

Summer:

- Capris, shorts, lightweight skirts
- Short sleeve and sleeveless tops
- Short sleeve and sleeveless dresses
- Sandals

Fall:

- Sweaters
- Long skirts
- Hats/scarves/gloves/mittens
- Light coats and jackets
- Boots

Winter:

- Wool/cashmere sweaters
- Hats/scarves/gloves/mittens
- Winter coats and jackets
- Ski wear
- Snow boots

What else do you accept for consignment besides clothing?

- Shoes, boots and sandals
- Accessories such as scarves, wraps, shawls
- Purses and bags
- Costume Jewelry

How does the consignment arrangement work?

- Prices are determined together by consignee and Mirror Mirror.
- Consignees will receive 50% of the selling price for new items with tags, with all the rest 40% of the selling price for all other items.
- Items accepted for consignment will be placed on sale for 90 days. After the initial 70 days, items will be discounted 25%.
- Unsold items should be picked up at the end of the 90 day period.
- Unsold items that are not picked up at the end of the 90 day period will be placed on a clearance rack for 30 days. At the end of those 30 days, any clearance rack items that have not been sold or picked up will be donated to charity.
- For account balances over \$50, a check will be mailed to you the first week of the following month. For account balances under \$50, the amount will accrue as a credit in your account, or the consignee may pick up check at the shop.
- Consignees receive 10% off any non-sale items purchased.
- All consignments are consigned with Mirror Mirror at owner's risk. Mirror Mirror Clothing Shop is not responsible for any loss by fire, theft, negligent handling or other causes.
